# **USN Nevada RN License Program\*\*\***

#### This program is limited to specific RN specialties.

Individuals selected for this program are based on nurse specialty. You must have verifiable work experience in the last two years in one of the following areas to be eligible for reimbursement.

- Cath Lab
- EP Lab
- CVICU- Must be able to care for fresh open hearts
- Operating Room
- CVOR
- Chemo Certified RNs
- ICU
- Labor & Delivery
- NICU- Must be able to attend deliveries
- PICC Lines- Must be able to insert PICC lines
- Wound Care

If you apply for a new nursing state license or renewal in Nevada between June 5, 2024 & June 14, 2024, license application fees up to \$200 will be reimbursed.

Reimbursement and expenses paid includes the application fee, license verification and background check fees. USN will not reimburse for postage, transcripts or coursework fees.

Qualified applicants will be reimbursed within 4-6 weeks **upon proof of an ACTIVE verifiable online Nevada license**. If you have never completed an assignment with Fastaff or USN, you MUST provide a W-9 IRS form with your receipt to be reimbursed.

You must obtain an active Nevada license AND be submitted to one of the Nevada state specialty positions listed above in order to receive reimbursement.

All Nevada license receipts must be emailed to <u>USNLicensing@usnursing.com</u> by <u>Friday</u>, <u>June 14, 2024</u> to qualify for reimbursement.

## **Obtaining Your Nevada Nursing License**

Endorsement Application Fee: \$100.00

- Apply Online Nevada Nurse Portal
- Applications and documents are processed in approximately one week. You can review
  the status of your application by logging into your nurse portal account and clicking on
  "view status."
- Once you've submitted your initial application Board staff will determine if you are eligible for a one-time temporary license, valid for six months.

#### **Verification of Licensure**

- Official verification (or endorsement) from your original state of licensure is required.
  - If your original state of licensure by examination is enrolled in Nursys Verification database, you MUST visit www.nursys.com to submit a Nurse License Verification for Endorsement request.
  - If your original state of licensure by examination does NOT participate in Nursys, you must send the <u>NSBN Endorsement Form</u>, to your original state of licensure by examination with their appropriate fee. Please contact your original state for additional instructions.

### **Official Transcripts**

- Submit a copy of your <u>official</u> transcript, issued directly from the registrar to the student or to the Board.
  - O Upload official transcripts or diploma with your application, mail directly to the Board, or email electronic transcripts to nursingboard@nsbn.state.nv.us.

### **Background Check**

Fingerprinting Fee: \$40.00

- Completed fingerprint card with submission form
  - o A permanent license will not be issued until the Board receives fingerprint results from the Nevada Dept. of Public Safety and Federal Bureau of Investigation.
